The Department of Pathology and Laboratory Medicine at the University of Vermont College of Medicine, in affiliation with our university hospital, The University of Vermont Medical Center, seeks a pathologist with expertise or interest in Laboratory Medicine to provide a consultative and leadership role in the Clinical Chemistry section of our Pathology services. This is a full-time position with a faculty appointment on the Clinical Scholar Pathway (non-tenure), with academic rank dependent on the applicant's prior experience and expertise. Strong quality management and laboratory management skills are desirable, as is past experience in validating and implementing new assays. Bioinformatics experience also is desirable. The ideal candidate will have scholarly interests, either in medical student, resident and/or fellow education and/or in clinical, translational and/or health services research. Candidates with strong research credentials also will be considered. Applicants who have a M.D.-Ph.D., M.D. or D.O., are board-eligible or certified in Clinical Pathology, and have additional Clinical Chemistry training or expertise are preferred. Applicants with a Ph.D. in a relevant area of science, who have completed or are completing a ComACC-accredited Clinical Chemistry fellowship, will also be considered.
